The following additions, deletions, changes or revisions are issued herewith and become a part of the Project Documents.

Specifications/Contract Documents:

- Item 1: The existing building on site will be removed by the Client including the footings.
- **Item 2:** Masonry Face Brick. Eliminate the first soldier course, 1/2" corbeled out at the bottom of the brick wall at the floor slab; all three sides.
- Item 3: The existing asphalt paving can remain where possible. (Note the front area of the site.)
- **Item 4:** Roof. A TPO 60 mil roof without a fleece backing with a 20 year warranty as manufactured by Versico is acceptable. The roof and the roof insulation can be mechanically fastened. Two layers of 3" polyisoyanurate is acceptable. The 1/4" cover board on top of the roof insulation is not required.
- Item 5: The rear downspouts shall be pre-finished 3" x 4".
- Item 6: The attached revised Section 00310 Bid Schedule must be used in bidding this contract.

Mechanical and Electrical:

Please make the following changes:

- Item 1: M.C. cable can be used as per electrical code.
- Item 2: Reference Sheet E-1; Remove sheet note 3. Light Fixture LF-A is non-emergency, Fixture E-3 is shown as the egress light.
